1. Answer is: C - The residents room from where the call was made from.

Ohio Admin. Code 3701-17-01 Definitions.

(GG) "Resident call system" means a set of devices that are connected electrically, electronically, by radio frequency transmission, or in a like manner that can effectively alert the staff member or members on duty, at the nurses' station or at another point in the nursing unit, of emergencies or resident needs and that can not be deactivated from any location except from where the resident initiated the call.

2. Answer is: C - Nurse Ellen should call in an emergency order from the pharmacy & also call Mr. Hall's daughter and explain that she must bring the medicine back to the facility immediately.

Ohio Admin. Code 3701-17-17 Medicines and drugs.

- (2) The nursing home, in conjunction with the pharmacist or pharmacy service, shall:
- (a) Maintain an emergency and contingency drug supply for use in the absence of the pharmacist; and
- (b) Ensure that the contingency drug supply is maintained in accordance with state pharmacy rules.
- (B) Medicines and drugs shall be given only to the individual resident for whom they are prescribed, shall be given in accordance with the directions on the prescription or the physician's orders, and shall be recorded on the resident's medication administration record

3. Answer is: D - Between 6am and 6pm

Ohio Admin. Code 3701-17-08 Personnel requirements.

(B) Each nursing home shall employ a registered nurse who shall serve as director of nursing. The director of nursing shall be on duty five days per week, eight hours per day predominantly between the hours of six a.m. and six p.m. to direct the provision of nursing services.
